Regarding Mr. Shadle, we find that he has already been a member of our confidential society and that we should have caught this at the time Troop 23 reregistered in June. There was one slight difference which probably accounts for why it wasn't picked up and that is because we previously had his name spelled Shadel. We have now corrected this so that we can pick it up should he ever again attempt to register. Of course, I am sorry that we didn't catch this in June - it might have saved you the embarrassment of handling the situation this summer in camp - but I am glad you caught it before it developed into anything serious.

Dear Howard:

Seems like when it rains it pours. I would like you to place on the National Council red flag list the following individuals: Joe Kaipo, 228 Brown Street, Iowa City, Iowa, who at the present time is registered with Post 208, Iowa City. Also James Lee Shadle, 413 34th Street N. E., Cedar Rapids, Iowa and I understand his other address is Maynard, Iowa, registered with Troop 23.

Mr. Kaipo has been serving as Post Advisor of Post 208. It was called to my attention about six months ago that he had Explorer Scouts in his apartment, although he is a married man with one child, at late hours. Upon investigation we could not find anything wrong. This summer he served as an advisor in taking a group of boys to Philmont Scout Ranch. I was informed that he instructed all of his boys to strip down to just shorts to make a five mile hike up Rayado and back, which they did. Upon his return to Iowa City after this trip, one of the boys in his Post complained to a leader, who in turn contacted our District Executive, stating that he had been approached by Mr. Kaipo. The District Executive then informed the committee of the Explorer Post as to his conversation with the boy. The committee, therefore, asked Mr. Kaipo to appear before them. As far as I can determine at the present time, or until I can receive written proof, Mr. Kaipo admitted that he had a tendency toward boys and through their recommendation he is taking treatment at the mental hospital of Iowa City. He admitted all of his approaches and his tendencies to approach boys. Upon this circumstantial evidence I would recommend that he be placed

on the red flag list. I have asked the chairman of his post committee to submit to me a letter relative to all of the meetings, conversations, results and as yet I have not received it, but I sincerely feel that it will be forthcoming, and in the meantime I recommend that Mr. Kaipō does not register with the Boy Scouts of America. The thing that I am concerned about is that I recently heard he is going in to Chicago for eight weeks to take special training for his company. I sincerely hope he will not be affiliated with the Boy Scouts of America while in Chicago.

The other man, James Lee Shadle, was employed by us at our camp this summer. After two weeks operation we had several boys approach our Camp Director that Mr. Shadle was making approaches towards them. The Camp Director and our professional man, Homer Miles, visited with Mr. Shadle, who admitted also at that time that he had been under treatment at the Mental Health Center in Cedar Rapids; that they had recommended that he obtain a job as working in a Boy Scout Camp, which they felt would help him. After contacting the Mental Health Center they stated that he was under treatment but they did not recommend his attending a Boy Scout Camp. In a conversation between myself and the advisor of the Mental Health Center this lady stated that Mr. Shadle was one man that should not be employed by any youth organization and that he had been taking treatment with the Mental Health Center and had also been interned in the Mental Institute at Independence, Iowa. Would you also, therefore, cross off Mr. Shadle's name and submit it to the Boy Scout red flag list. Mr. Shadle at the present time is living in Denver, Colorado and no doubt will try to enroll in the Boy Scouts of America.

Howard, if this is not sufficient evidence for you to place them on the red flag list would you please advise me so that I might gain further information.

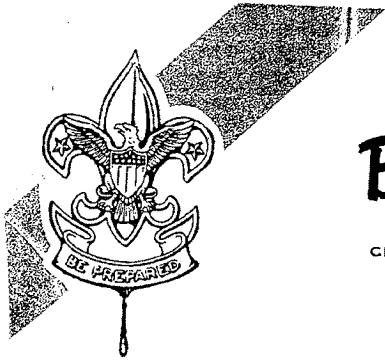

Four days ago, I received a call from Mr. Harry Krieg- Chief of Police- Waterloo, Iowa. He informed me that his officers had arrested Mr. JAMES SHADEL of 715 West Park Street, Waterloo, Iowa, on charges involving homosexual activity.


Chief Krieg stated that James Shadel had admitted the truth of the accusations. He did not mention the names of the persons making the charges I doubt very much that he would be willing to do so.

James Shadel is not registered at the present time. He was last registered as a Boy Scout in Readlyn, Iowa. It was his intention to register as Asst. Scoutmaster in Troop 1 of this Council-- the Scoutmaster of this troop informed me he has been helping on an informal basis for the past 30 days.

Shadel is 24 years of age--white--6'tall--is an epileptic-- as indicated, his home town is Readlyn, Iowa-- He currently resides in Waterloo.

Hope the above information is sufficient Basil, if not, drop me a line and I'll try to get additional information.
