The St. Louis Area Council, Boy Scouts of America feels compelled to put Robert L. Wantuck, 2703 Asbury Road, St. Louis 14 Missouri, former Advisor of Post 384 of this Council, and currently Advisor of Post 765, whose charter we are holding, on the Confidential File list.

Mr. Wantuck gave leadership to the drinking of both beer and whiskey by members of his Post, in his home, and at a country cabin where Explorer outings were held. Furthermore, he engaged in homo-sexual practices with members of the Post, offering money to these boys to influence them to submit to his advances.

Two Explorers, [redacted] and [redacted] gave detailed descriptions in the presence of an interview participated in by Rev. Elsworth Ewing, Pastor of Garden Chapel Community Church, Old Trails Explorer Advisor Charles Barth, Advisor of Post 384 and father of Phil Barth, and [redacted], an additional Explorer in the Post. The representative from our Executive Staff at the interview was C. Kenneth Swink, Field Director.
