Dear Howard:

We were notified today by the King County Sheriff that a Mr. Clifford G. Wysong had been picked up and placed in the County jail on a morals charge. Mr. Wysong has been registered as Assistant Cubmaster of Pack 323, sponsored by First Hill Improvement Club, 916 Minor, Seattle, Wash.

The Sheriff's office said that Wysong had signed statements admitting seven years of indecent liberties with [redacted] and two years with [redacted]

A brief account of these indecencies is noted on the attached slip together with a mug shot and description of Mr. Wysong.

The Sheriff's office has told us that they will return his Scout registration card to us, and we request that he be listed in the Confidential File to prevent re-registration at a future date.

In addition to the information shown on the mug shot and description, we understand that he is white, and claims a Protestant religious connection.
