Gentlemen:

This is a report on Mr. Tim Fleming who is registered in Troop 364 in the Old Kentucky Home Council.

This came to light initially through Mr. William Spillman, one of our veteran Scouters and a former district chairman. Mr. Spillman is also a member of the sponsoring institution, the Audubon Baptist Church. A Mrs. [REDACTED] who has two sons in the troop came to Mr. Spillman and complained that Mr. Fleming had taken her son, [REDACTED], pants off and had rubbed his privates.

We had Mrs. [REDACTED] come into the office, along with Mr. Spillman, and interviewed them.

Enclosed is a copy of the letter Mrs. [REDACTED] wrote and Mr. Spillman heard from other parents about this incident.

Mr. Spillman had already talked to the pastor of the church by the time the Scout Office was informed and Mr. Spillman who is familiar with registration procedures initiated the action to call Mr. Fleming in and suggested that he not be active in Scouting any further.

A meeting was held with Mr. Spillman and Mrs. [REDACTED] and Tim Fleming, and Mr. Fleming agreed to leave Scouting. He is single, 27 years of age and active in the church, including being a deacon and sings in the choir.



Dear Mr. Cary,

I am writing at the suggestion of a Mr. William Spillman, a local Scouting Official, who indicated that I should report to you a matter of grave concern to Scouting in general.

Sometime ago it came to my attention that a Boy Scout leader of Troop 364, Mr. Don Fleming, was encouraging, and possibly engaging in, homosexual acts with selected members of Troop 364 on various occasions when he was alone with them at Scout functions. These alleged acts were admitted to me by my two sons who were members of the Troop and

were confirmed in a general manner by Mr. Fleming during a meeting with Mr. Spillman and myself. At that meeting I offered Mr. Fleming an opportunity to seek professional assistance, and he agreed to consider my recommendation and to let me know his decision within a reasonable time. Approximately three months have elapsed and I have not been contacted.

I am currently undecided as to whether I should pursue the matter with police authorities. However, I have been let to understand by Mr. Spillman, that this letter will serve as your authority to initiate appropriate action to see that Mr. Fleming's name is entered into a permanent

against him ever becoming
involved in Scouting in the
future. I kindly request that
you take such actions as are
necessary to preclude his asso-
ciation with Scouts in the
future.
