The Indian Trails Council wishes to report that we have received certain information concerning a Scouter registered in the Council which has precipitated a course of action. The Scouter is David Follett, 24 Montauk Avenue, New London, Ct., 06320, registered with Troop 61 (national number, 561) sponsored by the Salvation Army in New London, Ct.

Information came to us indicating that Follett had been convicted of a sexual offense involving young boys. Upon receiving this information, it was followed up by a contact with a State Police officer in the State Attorney's Office in New London. They confirmed the information that we had received.

In 1964 Follett had been convicted of child molesting and spent the next four years in prison. Follett was contacted and informed that because of the situation, he would have to leave Scouting. A resignation to that effect is enclosed. At this time Follett stated that the Council's information was correct, and that he understood that he would have to stay out of Scouting.
